

## **About Enrolled Agent (EA)**

An Enrolled Agent (EA) is a tax professional authorized by the U.S. Department of the Treasury to represent taxpayers before the IRS. EAs are experts in U.S. tax laws, specializing in tax preparation, advisory, and resolving tax-related issues for individuals and businesses. This prestigious designation is earned by passing the rigorous Special Enrollment Examination (SEE) or through qualifying IRS experience.

At Saraf Academy, we provide specialized training for aspiring EAs, led by renowned industry expert and educator Mr. Kaushal Subudhi. Our program equips students with the knowledge and skills needed to excel in the SEE and build a successful career as a trusted tax professional.



### **EA Program Highlights**

Helps you spark your career in a short time frame of just 6-8 months with around 100-150 hours of study.
 One unique aspect of becoming an EA is that there are no specific education or experience requirements to begin, making the path to becoming an EA accessible and open to anyone.

The SEE consists of **three parts**, each focusing on a specific area of taxation:

Part 1: Individuals
Part 2: Businesses
Part 3: Representation, Practices, and Procedures

- The exam is conducted as a **computer-based test (CBT)** at Prometric testing centers.
- Duration:
  - Each part of the exam is **3.5 hours** long.
  - A total of **105 multiple-choice questions** are included per exam part:
  - 85 scored questions
    20 unscored pre-test questions
  - The unscored questions do not affect the final result but are used for testing future exam content.
- Passing Score:
  - The passing score for each part is **105 out of 130** (scaled scoring).



### **EA Program Highlights**

#### 3. Exam Windows

- The SEE is offered **year-round**, with the exception of the following blackout periods:
  - March and April of each year.
- Candidates can schedule exams at their convenience during open testing windows from:
  - May 1 through February 28/29 of the following year.
- Retakes:
  - Candidates can retake any part they fail, up to **four times per year** per exam part.





### **Exam Pattern**



The **100 multiple-choice questions** that make up **each exam include 15 experimental questions**. The topics of the experimental questions cannot be known, so this breakdown accounts for the remaining 85 questions. **The IRS sets** a scaled passing score at **105 out of the available 130 points**.



# **After Earning EA**

#### How to Maintain the EA Credential?

Once you become an EA, you are required to:

- **Renew your status** every three years.
- Renew your PTIN (Preparer Tax Identification Number) between mid - October - December 31 of each year.
- Meet Continuing Education Requirements, which include 72 hours every three years (minimum of 16 hours per year, two of which must be on ethics).


